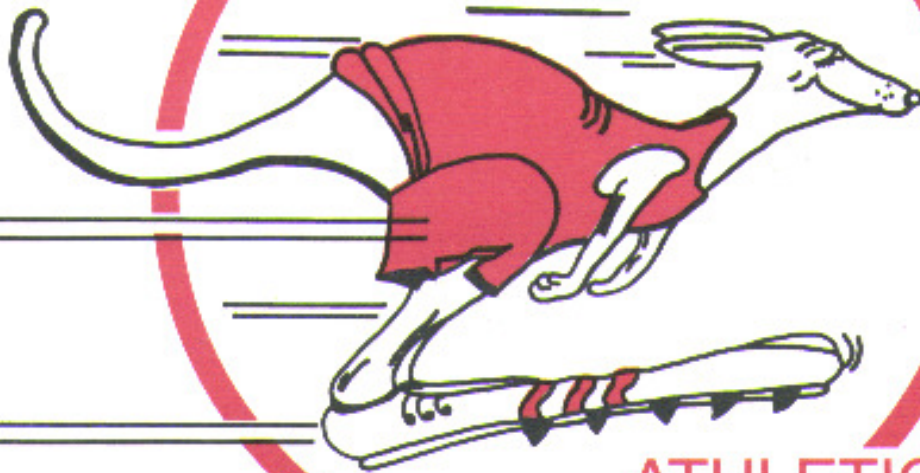

## **Treasurer's Report 2019-2020**

For the year ending 30<sup>th</sup> June 2020, the Eastern Suburbs Athletic Club Inc. recorded a trading profit of \$5,385.75. The club holds an inventory of clothing valued at \$2,903.90 and has assets valued at \$4,390.

The balance of the working account was \$11,007.31 as at 30<sup>th</sup> June 2020, and the term deposit was \$35,866.91. It is due to mature on 19/07/2020.

The income and expenditure statement is provided with this report. The Round the River Fun Run, unfortunately could not be held this year due to the Coronavirus pandemic. However, we would like to extend our thanks to Roger Hosie of RSM Insurance for his support of the event this year, as well as our ongoing sponsorship from Raine and Horne Eastern Shore and Your Health Hub. At this stage, we are hoping the event will be held in August, and any further income/expenditure will appear in the 2020-21 report.

This year a payment of \$132 was made to Athletics Tasmania for the 2018/2019 club relay costs. These were not paid last year due to the timing of Athletics Tasmania raising their invoice for the event.

The club has continued to invest in new uniforms and clothing, which accounts for \$2,261.20 of the total expenditure for the year.

The shade tent damaged at the Australian Little Athletics Championships last March (2019) has been replaced.
